The IQAC prepares Academic Calendar in accordance with the University schedule at the beginning of the academic session and it is uploaded to the college website. 2. The College provides the students' with the maximum available flexibility in choice of courses under the CUCBSS for UG and CCSS for PG programs. 3. Orientation/Induction program for newly admitted students enriches their understanding of their respective curricula and its timely deliverance. 4. There is a well organised method for timely delivery of curriculum stipulated by Academic Committee and the College Council adhering to teaching, class, and tutorial schedules. 5. According to syllabus distribution, each faculty prepares teaching plans according to the no of lecture hours allotted to him/her. 5.Blending of variety of methods including audio-visual aids, ICT tools, promoting student projects, assignments, and seminars. 6. Tutorials and Continuous Internal Examinations are used to identify student-specific talents, needs, and learning difficulties. 7. Field Trips are organised by the Science departments for the effective implementation of curriculum. 8. A forum for constructive dialogues and discussions are created through regional. national and international seminars, workshops. 9. Extra curricular activities are actively encouraged which has time and again proved beneficial to student populace for their overall development 10. Student Satisfaction Survey is conducted by IQAC to improve teaching-learning process. Each and every activity conducted under the aegis of clubs, committees, or departments are documented. Feedback Obtained

Feedback is essential for the proper evaluation and the uplift of any institution. Feedback on the teaching and learning process is received from the Student Satisfaction Survey. Apart from the feedback of students parents feedback are also collected. IQAC conducts feedback by the students every year. Each student gives feedback for their respective courses- both theory and practical taught to them. The general assessment points are based on curriculum, evaluation procedure, satisfaction about teaching methodology, teachers approachability towards students to name a few on a 5 point scale. The feedback on curriculum analyses its contents and coverage, scope for higher education and employability, grading system, and pedagogical updation at periodic intervals. The feedback from students of all programs is collected by IQAC simultaneously. The students provide feedback on individual faculty members, the overall performance of the department, and also on the Institution as a whole. Feedback from parents is collected during PTA meetings. Their valuable opinion on curriculum, department, course outcomes, and on the overall progress of the student is sought. The policy followed by the institution is that the overall performance of individual faculty and the departments are forwarded to the Head of the Department by IQAC for corrective measures, if any. The observation of the parents collected through the feedback is intimated to the Head of the Institution and forwarded to the management for any action necessary.

2.3.2 – Students mentoring system available in the institution? Give details. (maximum 500 words)

The Institute has a well defined policy of mentoring its students who come from various socio-economic backgrounds- rural, tribal, and semi-urban locales. The newly admitted students are given Induction program to facilitate their smooth transition into higher education system. Each and every class has a tutor-in-charge allotted by the Head of the respective department. Every student is thus brought into the mentoring program under the tutorial system implemented by the Institution. The mentees share personal details, ideas, academic and cocurricular interests, aspirations, and ambitions with their mentors. the mentor meets the mentees at least twice a month. the ongoing relationship which continues even after their course is over is nurtured through phone calls and social media apps. Walk with a Scholar program, an initiative of the Higher Education Council of the Government of Kerala is built around the concept of mentor as Guide and Friend designed for undergraduate students to prepare them for higher education, research, or employment. A total no of 60 students were selected from first and second year UG classes based on the result of an aptitude test. Ten mentors were selected from among the faculty and a group of six students were allocated to each. This program also includes external mentoring sessions by eminent personalities from various walks of life. ASAP is another program that focuses on enhancing communicative skills and knowledge of IT through various practical sessions. Additional Skill Acquisition Program (ASAP) has 32 students enrolled in it with a faculty as Coordinators. The external faculty specially trained by the government for this program handles the sessions. Apart form these programs, Student Support Program (SSP) for poor learners are present to uplift them to a higher level of potential. Remedial coaching is arranged by particular departments too. The mentors/ trainers/facilitators keep detailed progressive records of the mentees.

The Institution has a well developed system of CIE implemented as per university norms and perfected over the years under the choice based semester system at both UG and PG levels. Apart from the conventional Internal test papers conducted every year under a centralised system, there is also continuous oral tests, debates, discussions, group discussions, seminar presentations and practical exercises. The learner is given plenty of opportunities to improve knowledge base, skill acquisition and practical hands-on training for increasing employability. An overall development of each student-learner is required for the holistic development of the institution.

Each department mentors its students to achieve this goal.

2.5.3 – Academic calendar prepared and adhered for conduct of Examination and other related matters (250 words)

The IQAC prepares a College Academic Calendar at the beginning of the year in accordance with the University Calendar. This Calendar is distributed to all the departments and the students too are informed of the their semester-wise schedule, list of holidays, and date of Internal examinations. Term wise teaching plan is prepared by each faculty according to the portions allotted. A work diary is also maintained by each member. Different committees are formed at the beginning of each academic year. The coordinators propose a plan of action of the activities to be conducted during the course of the year. Tentative dates of council meetings, other administrative and academic bodies are also given. Programs and activities like College Union elections, Cultural programs, Sports Day, Arts Fest are also provided. PTA meetings are also conducted to collect feedback of the parents/guardians regarding their wards performance. A follow up of their suggestions are also effected wherever necessary.
